STIPULATION

1. Respondent, Reba N. Brooks is a licensed insurance agent in the State of Utah, holding License No. 83557.
2. Respondent stipulates with the Complainant, Utah Insurance Department, as follows:
 - a. If a hearing were held, witnesses called by the Complainant could offer and introduce evidence that would support the Findings of Fact herein;
 - b. Respondent admits the Findings of fact and Conclusions made therefrom;
 - c. Respondent stipulates to the Summary entry of the Order herein which

shall be in lieu of other administrative proceedings by Complainant in this matter; and

d. Respondent and Complainant have negotiated the terms of the Order entered herein and Respondent agrees to its entry and further agrees to be bound by all its terms.


3. Respondent is aware of her right to a hearing at which she may be represented by counsel, present evidence and cross-examine witnesses. Respondent has irrevocably waived her right to such hearing and to any appeal related thereto.

4. Respondent admits the jurisdiction of the State of Utah Insurance Commissioner as to all matters herein.


5. Respondent is acting herein free from any duress or coercion of any kind or nature, having been advised fully as to her rights set forth herein.

6. Respondent acknowledges that the issuance of this Order by the Commissioner is solely for purpose of disposition of the matter entitled herein.

Based upon the foregoing Stipulation and information in the file, the Presiding Office makes the following Findings of Fact:

FINDINGS OF FACT

1. The Producer Licensing Division received notice from the National Association of Insurance Commissioners (NAIC), regarding the Missouri Insurance Department's May 29, 2009 administrative action against the license of Respondent. As a result of a Market Conduct referral, the following facts were found to exist.

2. The Respondent Reba N. Brooks is a resident of Georgia residing at 1388 Chrisitana Drive, Lawrenceville, GA 30243.

3. A Private Letter of Admonition was issued by the Department on April 7, 2009 to the Respondent for her failure to report an October 2008 administrative action taken against her license by the State of Virginia.

4. In her April 7, 2009 letter to the Department, Respondent acknowledges receipt of the Private Letter of Admonition and makes the statement that she understands she is to "report any violation or revocation that occurs against me within a thirty day period."

5. The action taken against Respondent in Missouri was due in part to her failure to report within 30 days the action taken against her in Virginia.

Based upon the foregoing Stipulation and Findings of Fact, the Presiding Officer enters the following Conclusions of Law:

CONCLUSIONS OF LAW

1. Utah Code Ann. §31A-23a-105(2) (West 1009) requires a licensed individual to report to the Commissioner any administrative action taken against that individual's license in another jurisdiction within 30 days of the final disposition of the administrative action.

2. By failing to report that administrative action taken in Virginia and Missouri, Respondent violated Utah Code Ann. § 31A-23a-105a(2).

3. An administrative forfeiture of \$500.00 and probation for a term of 12 months is appropriate under the circumstances.

Based upon the foregoing Stipulation, Findings of Fact and Conclusions of Law, the Presiding Officer herewith enters the following Order:

ORDER

IT IS HEREBY ORDERED:

1. Respondent Reba N. Brooks is assessed an administrative forfeiture in the amount of \$500.00 to be paid to the Utah Department of Insurance within thirty days of issuance of this Order.

2. Respondent Reba N. Brooks is placed on probation for a period of 12 months beginning from the date of this Order. The terms of probation are that Respondent shall pay the administrative forfeiture in a timely manner and shall have no further violations of the Utah Insurance Code or Rules or any order by the Commissioner.

NOTIFICATION

Respondent is hereby notified that failure to abide by the terms of this Order may subject you to further penalties, including additional forfeitures of up to \$2,500.00 per violation and the suspension or revocation of your license, and the filing of an action to enforce this Order in the District Court, which may impose penalties of up to \$10,000.00 per day for continued violation.

You are further notified that other jurisdictions in which you may be licensed may require that you report this action to them.


