**STIPULATION**

1. Respondent, Michael Bruce Beckman is a non-resident licensed insurance agent in the State of Utah, holding License No. 74707.

  - b. Respondent admits the Findings of Fact and Conclusions made therefrom;

- c. Respondent stipulates to the summary entry of the Order herein which shall be in lieu of other administrative proceedings by Complainant in this matter; and
- d. Respondent and Complainant have negotiated the terms of the Order entered herein and Respondent agrees to its entry and further agrees to be bound by all its terms.




4. Respondent admits the jurisdiction of the State of Utah Insurance Commissioner as to all matters herein.

Based upon the foregoing Stipulation and information in the file, the Presiding Officer makes the following Findings of Fact:

**FINDINGS OF FACT**

1. On or about March 25, 2009, the State of Vermont concluded an administrative action against Respondent for failure to report to Vermont an administrative action taken against him by another state.

2. A check of Department records indicated that Respondent had failed to report the Vermont and other states' administrative actions to the Utah Department of Insurance.

3. Upon being contacted by a Department investigator, Respondent stated that he had been having health problems and had recently hired a compliance officer to assist him.

4. Respondent thereafter provided the necessary documentation to the investigator and agreed to an administrative forfeiture in the amount of \$250.00.

Based upon the foregoing Stipulation and Findings of Fact, the Presiding Officer enters the following Conclusions of Law:

**CONCLUSIONS OF LAW**

1. By failing to disclose to the Commissioner within thirty days administrative actions taken against him by other states, the Respondent violated Section 31A-23a-105.

Based upon the foregoing Stipulation, Findings of Fact and Conclusions of Law, the Presiding Officer herewith enters the following Order:

**ORDER**

**IT IS HEREBY ORDERED:**

1. Respondent Michael Bruce Beckman is assessed an administrative forfeiture to be paid within 30 days of the date of this Order..


**NOTIFICATION**

Respondent is hereby notified that failure to abide by the terms of this Order may subject you to further penalties, including additional forfeitures of up to \$5,000.00 per violation and the suspension or revocation of your license, and the filing of an action to enforce this Order in the District Court, which may impose penalties of up to \$10,000.00 per day for continued violation.

You are further notified that other jurisdictions in which you may be licensed may require that you report this action to them.


