ORDER TO SHOW CAUSE

The commissioner has received notice under Utah Code Annotated § 31A-35-504(2)(b) of the Respondent's failure to pay a Judgment of Bail Bond Forfeiture within 15 days (18 days if the notice was mailed) after service of notice on the Respondent of the entry of the following judgments:

Third District Court vs. Jonathon Santos Hepolito, case #091904161 (a copy of the Judgment and Notice are attached hereto as **Exhibit A**).

Under Utah Code Annotated § 31A-35-504(3), the commissioner is required to suspend the license of the Respondent within 5 days of the receipt of the above notice. If a suspension is imposed, said suspension will continue until lifted under Utah Code Annotated § 31A-35-405(5).

Based upon the forgoing and good cause otherwise appearing:

IT IS HEREBY ORDERED:

1. Respondent shall appear before the commissioner or his designated representative on Monday, the 22nd day of February, 2010, at the hour of 9:00 a.m. to show cause, if any there be, why Respondent's license as a bail bond surety company in the State of Utah should not be immediately suspended pursuant to Utah Code Annotated §§ 31A-35-504(3) and 63G-4-502.

2. The hearing shall be limited to the following issues:

- a. has a judgment of bail bond forfeiture been issued against the Respondent;
- b. was a notice of entry of the judgment served on the Respondent at least 15 days prior to the notice to the commissioner of the failure to pay the judgment;
- c. was a motion to set aside the judgment of bail bond forfeiture or an application for an extraordinary writ filed within 15 days of the notice of entry of bail bond forfeiture; and
- d. has the judgment of bail bond forfeiture been paid?



This matter having come on for hearing on JUNE 10, 2009 and the bonding company having been given notice of defendant's failure to appear as required and the bond having been ordered forfeited and a Judgment of Forfeiture entered DECEMBER 18, 2009;

IT IS REQUIRED that the surety shall pay a judgment no later than 15 days following service of notice in accordance with Section 31A-35-504 et. seq. Utah Code Annotated 1953, as amended. If the judgment remains unpaid for more than 15 days, the prosecutor shall notify the Commissioner of Insurance of the surety's failure to pay the judgment. 




