STIPULATION AND ORDER

STIPULATION

1. Respondent Kim Keith Payne is a resident insurance producer in the State of Utah holding license No. 208359.
2. Respondent stipulates with the Complainant, Utah Insurance Department, as follows:
 - a. If a hearing were held, witnesses called by the Complainant could offer and introduce evidence that would support the Findings of Fact herein;
 - b. Respondent admits the Findings of Fact and Conclusions made therefrom;

- c. Respondent stipulates to the summary entry of the Order herein which shall be in lieu of other administrative proceedings by Complainant in this matter; and
- d. Respondent and Complainant have negotiated the terms of the Order entered herein and Respondent agrees to its entry and further agrees to be bound by all its terms.

3. Respondent is aware of his right to a hearing at which he may be represented by counsel, present evidence and cross-examine witnesses. Respondent has irrevocably waived his right to such hearing and to any appeal related thereto.


4. Respondent admits the jurisdiction of the State of Utah Insurance Commissioner as to all matters herein.

5. Respondent is acting herein free from any duress or coercion of any kind or nature, having been advised fully as to his rights set forth herein.

6. Respondent acknowledges that the issuance of this Order by the Commissioner is solely for purpose of disposition of the matter entitled herein.

Based upon the foregoing Stipulation and information in the file, the Presiding Officer makes the following Findings of Fact:

FINDINGS OF FACT

1. On February 4, 2008, Respondent entered a plea of “no contest” to three class A misdemeanor counts of sexual battery. Respondent also entered a plea of “no contest” to a 3rd degree felony of unlawful conduct with a 16 or 17 year old. The felony plea was held in abeyance pending successful completion of probation.
2. On October 27, 2009, the Respondent successfully completed his probation and the felony charge was dismissed.
3. Respondent failed to report the criminal charges and convictions to the Department and failed provide the documentation required.
4. When contacted by the investigator, Respondent fully cooperated and took responsibility for his actions.

Based upon the foregoing Stipulation and Findings of Fact, the Presiding Officer enters the following Conclusions of Law:

CONCLUSIONS OF LAW

1. Utah Code Ann. § 31A-23a-105 requires that a licensed individual or agency producer report to the commissioner any criminal prosecution taken against the person in any jurisdiction. The report is to be filed at the time the person files an application for a license or within 30 days of the initial appearance before the court. In addition, the report must include a copy of the complaint or other relevant documents related to the action or prosecution.
2. By failing to report the above charges and conviction to the commissioner,

Respondent violated the above statutory provision.

3. An administrative forfeiture in the amount of \$500.00 is appropriate in this matter.

Based upon the foregoing Stipulation, Findings of Fact and Conclusions of Law, the Presiding Officer herewith enters the following Order:

ORDER

IT IS HEREBY ORDERED:

Respondent Kim Keith Payne is hereby assessed an administrative forfeiture of \$500.00 to be paid to the Commissioner within 30 days of entry of this Order.
