FINDINGS OF FACT

1. Great Republic Life Insurance Company is an insurer domiciled in the State of Washington and authorized to do business in the State of Utah, Utah Organization Identification Number 1115.
2. Great Republic Life Insurance Company has applied to withdraw from the State of Utah and for a Release From Regulation by letter dated April 11, 2012.
3. With its request, Great Republic Life Insurance Company filed its Certificate of Authority with the Utah Insurance Commissioner.

4 Great Republic Life Insurance Company has ceased doing any new business in the State of Utah.

5. Great Republic Life Insurance Company currently has no policyholders in the State of Utah and all Utah obligations of Great Republic Life Insurance Company have been fully satisfied.

6. Great Republic Life Insurance Company has met all other requirements for release from regulation in the State of Utah and the release of Great Republic Life Insurance Company from regulation will not otherwise be prejudicial to the interests of insureds or creditors in Utah.

Based upon the above Findings of Fact, the Commissioner now enters the following:

CONCLUSIONS OF LAW

1. Great Republic Life Insurance Company has met all requirements for Release From Regulation pursuant to Utah Code Annotated § 31A-14-216, and an Order of Release From Regulation should, therefore, issue.

Based upon the foregoing Findings of Fact and Conclusions of Law, the Commissioner now enters the following:

ORDER


IT IS HEREBY ORDERED:
