**FINDINGS OF FACT**

1. Educators Health Plans Health, Inc. is an insurer domiciled and authorized to do business in the State of Utah, Utah Organization Identification Number 14728.
2. Educators Health Plans Health, Inc. filed a plan of dissolution and withdrawal from the state, which plan was approved by the commissioner.
3. With its request, Educators Health Plans Health, Inc. filed its Certificate of Authority with the Utah Insurance Commissioner.
4. Educators Health Plans Health, Inc. has ceased doing any new business in the State of Utah.
5. Educators Health Plans Health, Inc. currently has no policyholders in the State of Utah and all Utah obligations of Educators Health Plans Health, Inc. have been fully satisfied.
6. Educators Health Plans Health, Inc. has met all other requirements for dissolution and release from regulation in the State of Utah and the release of Educators Health Plans Health, Inc.

from regulation will not otherwise be prejudicial to the interests of insureds or creditors in Utah.

Based upon the above Findings of Fact, the Commissioner now enters the following:

**CONCLUSIONS OF LAW**

1. Educators Health Plans Health, Inc. has met all requirements for Dissolution pursuant to Utah Code Ann. § 31A-5-504, and an Order of Release From Regulation should, therefore, issue.

Based upon the foregoing Findings of Fact and Conclusions of Law, the Commissioner now enters the following:

**ORDER**

IT IS HEREBY ORDERED:

1. The surrender of the Certificate of Authority of Educators Health Plans Health, Inc. is hereby accepted and Educators Health Plans Health, Inc. is hereby released from regulation in the State of Utah as of the date of this Order.
