**STIPULATION
AND ORDER**

The Utah Insurance Department (“Department”), by and through its attorney, Perri Ann Babalis, Assistant Attorney General, and Aladdin Bail Bonds Utah, LLC (“Respondent”), a licensed resident limited line producer organization, hereby stipulate and agree as follows:

STIPULATION

1. Respondent, Aladdin Bail Bonds Utah LLC, is a licensed resident limited line producer organization, holding license number 513064. Respondent's mailing address is [REDACTED]

2. Respondent admits that the Utah Insurance Commissioner has jurisdiction over Respondent and over the subject matter of this action.

3. Respondent acknowledges notice of agency action pursuant to Utah Code Ann. § 63G-4-210; further acknowledges that this Stipulation and Order is an informal proceeding pursuant to Utah Code Ann. § 63G-4-202; and waives the right to any hearing in this matter.

4. Respondent affirms that Respondent enters into this stipulation voluntarily and knowingly.

5. Respondent affirms that the only promises, agreements, or understandings the Respondent has obtained from the Department or from an agent or representative of the Department regarding this stipulation are contained herein.

6. Respondent acknowledges that Respondent has the right to be represented by legal counsel and that Respondent has consulted legal counsel with regards to this stipulation.

7. The parties acknowledge that upon approval by the Respondent and the Department, this stipulation shall be made a part of the attached final Order, and shall be the final compromise and settlement of this matter, and is not subject to agency review, reconsideration, renegotiation, modification, appeal, or hearing.

8. The Department alleges that Respondent failed to submit all required documentation as

part of the required information for an initial agency application. Specifically, the Department alleges that Respondent failed to report an administrative action from the State of Idaho to the Department.

9. The Department alleges that the above acts and practices constitute violations of the Utah Insurance Code. Specifically, the Department alleges that Respondent has violated:

- a. Utah Code Ann. § 31A-23a-105(2), in that Respondent failed to file, at the time of initial application, an administrative action taken against Respondent in another jurisdiction; and
- b. Utah Administrative Code, Rule 590-244-4, in that Respondent failed to submit electronically to the Department using SIRCON or NIPR all documents related to reporting administrative action taken against Respondent.

10. Respondent denies the allegation in Paragraphs 8 and 9 above and asserts as follows:

- a. Respondent fully and correctly completed its Utah initial agency application;
- b. The Idaho matter described in Paragraph 8 did not involve Respondent, but rather a separate and distinct entity; and
- c. The Idaho matter was not an “administrative action” required to be disclosed in the initial agency application.

11. Notwithstanding the above, as full settlement of all of the issues raised in the stipulation, Respondent agrees to pay a forfeiture of \$750.00 to the Department, due within 30 days from the date of the Order, and to be placed on probation for 24 months.

ORDER


IT IS HEREBY ORDERED:
