- 2. Respondent failed to pay the title assessment for calendar year 2013 by the due date of November 30, 2014.
- 3. The Department emailed a courtesy reminder on December 11, 2014 and received no reply.
 - 4. As of the date of this agency action, no replies or payments have been received.

BASED UPON THE FOREGOING FACTS

l. In failing to pay the title assessment for calendar year 2013 by the due date of November 30, 2014, Respondent violated Utah Code § 31A-23-415 and Utah Admin. Rule R592-10-8.

Based upon the foregoing facts, the Commissioner now enters the following Order:

IT IS HEREBY ORDERED:

- l. Respondent is assessed an administrative forfeiture in the amount of \$1,000.00. Said forfeiture shall be paid no later than ten (10) days after the date this Order becomes final.
- 2. This Order shall become final fifteen (15) days after the date of mailing unless a written request for a hearing is received from the Respondent in the offices of the Department prior to that date. A written request for a hearing shall be signed by the person making the request and shall state the basis for the relief requested.
