Based upon the foregoing Stipulation and Department file, the Presiding Officer makes the following Findings of Fact:

FINDINGS OF FACT

- 1. Respondent holds a Resident Limited Line Individual Producer License with the qualification of bail. Respondent owns and operates Price Bail Bonding..
- On May 31, 2013, Respondent allowed his license to lapse. At that time,
 Respondent's associations were automatically terminated on SIRCON.
- On June 10, 2013, Respondent reinstated his license, however his association to
 Price Bail bonding was not updated until October 9, 2015.
- 4. Respondent continued to write bail on behalf of Price Bal Bonding during the time his association was lapsed. From June 1, 2013 through October 8, 2015, Respondent wrote 639 bonds for Price Bail Bonding. The amount of premiums collected on those bonds totaled \$269,591.00.
- 5. An investigation was conducted by Department personnel into this matter. A recommendation of an administrative forfeiture in the amount of \$2,500.00 was made. On January 28, 2016. Respondent agreed to the recommended forfeiture in the amount of \$2,500.00.

Based upon the foregoing Stipulation and Findings of Fact, the Presiding Officer enters the following Conclusions of Law:

CONCLUSIONS OF LAW

- 1. Utah Code Sections 31A-35-102 (2)(a) (ii)(b) and (c) defines a bail bond producer as one who is appointed by a bail bond surety.
- 2. Utah Code Sections 31A-23a-205 (2) and 31A-35-402 require that a boil bond producer must have an appointment to write bail bonds in this State.
- Utah Administrative Rule R590-186-6 addresses licensure and renewal provisions for bail bond agents.
- 4. Respondent violated the above authorities when he allowed his license and appointment to lapse and, upon license reinstatement, he failed to renew his appointment to Price Bail Bonding, all the while continuing to write bail.
- 5. Imposition of the agreed forfeiture in the amount of \$2,500.00 is appropriate in this matter and under the circumstances.

Based upon the foregoing Stipulation, Findings of Fact and Conclusions of Law, the Presiding Officer herewith enters the following Order:

ORDER

IT IS HEREBY ORDERED:

Respondent Bert J. Christenson is hereby assessed an administrative forfeiture in

the amount of \$2,500.00 to be paid to the Department within 30 days of the date of this

Order.
