The parties have stipulated that the Presiding Officer may enter this order. Based on the stipulation, and good cause appearing, it is ordered:

1. Fast N Furious Bail Bonds (“FNF”) will pay a penalty in the amount to \$3,500 to the Utah Insurance Commissioner within 30 days of the date of this order.

2. FNF will be on probation for 24 months beginning the date of this order. The terms of probation are as follows:

A. A representative of FNF will meet with a representative of the Utah Insurance Department every six months. At each meeting, FNF will present for review all records concerning the trust account that it maintains in connection with its operations. The


purpose of the review is to assure that FNF is complying with the laws concerning trust accounts.

B. FNF will not violate an insurance statute or rule.

3. If FNF does not satisfactorily complete probation, it will be obligated to pay an additional \$3,500 to the Utah Insurance Commissioner for violating the terms of probation.


