FACTS

- 1. Respondent is a resident title insurance agency authorized to do the business of insurance in the State of Utah holding License Number 536580.
- Respondent failed to file its Annual and Controlled Business reports for calendar year2016 by the annual due date of April 30.

BASED UPON THE FOREGOING FACTS

In failing to timely file the 2016 Annual and Controlled Business reports when due, the Respondent violated Utah Code Ann. §§ 31A-23a-413 (2015) and 31A-23a-503(8) (2013) and Utah Admin. Rule R592-11-3 and 4.

Based upon the foregoing facts, the Commissioner now enters the following Order:

<u>ORDER</u>

IT IS HEREBY ORDERED:

- 1. Respondent is assessed an administrative forfeiture in the amount of \$1,000.00 pursuant to Utah Code Ann. § 31A-2-308 (2012). Said forfeiture shall be paid no later than ten (10) days after the date this Order becomes final.
- Respondent shall file the 2016 Annual Controlled Business reports no later than ten
 days after the date this Order becomes final.
- 3. This Order shall become final fifteen (15) days after the date of mailing unless a written request for a hearing is received from the Respondent in the offices of the Department prior to that date. A written request for a hearing shall be signed by the person making the request and shall state the basis for the relief requested.
