Complainant Utah Insurance Department ("the Department") and Respondent B & B Bail Bonds, LLC ("Respondent") have stipulated to entry of the following Findings of Fact, Conclusions of Law, and Order. Based on that stipulation, and good cause appearing, the Presiding Officer makes and enters the following:

FINDINGS OF FACT

1. Respondent is a Utah limited liability company that was formed in 1999 as a bail agency to engage in bail bond business. At all relevant times, Respondent has been licensed by the Department as a Resident Limited Line

Producer Organization.

2. Respondent uses form documents in conducting its bail bond business.

3. Due to a change in the law, Respondent was required to change the content of those forms effective May 10, 2016.

4. The law further required that those forms be filed with the Department before first being used.

5. On 58 occasions since May 10, 2016, Respondent used those forms but did not first file them with the Department.

CONCLUSIONS OF LAW

1. The Utah Insurance Commissioner has jurisdiction over the parties and this formal proceeding pursuant to Utah Code §§ 31A-1-105, 31A-2-201 and 31A-2-308.

2. The Utah Insurance Commissioner has legal authority to impose penalties on the Department's licensees who violate the Utah Insurance Code. Utah Code § 31A-2- 308.

3. Beginning May 10, 2016, Utah law required each bail agency to list its business email address on all forms required to be filed with the Department. Utah Code § 31A-35-607(b)(ii).

4. Utah law further required that those forms be filed 30 days before they were first used. Utah Code § 31A-35-607(2).

5. By using unfiled forms in its bail bond business as set forth in Findings of Fact Nos. 2-5, Respondent committed 58 violations of Utah's

insurance law.

6. As penalty for the violations, Respondent should be ordered to pay a forfeiture of \$5,000.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, it is ordered that Respondent shall pay a forfeiture of \$5,000 for the violations described above.
