This matter came before the Presiding Officer on September 20, 2018 for a telephone prehearing conference. Present were Helen A. Frohlich and Perri Babalis, Assistant Attorneys General for the Utah Insurance Department, Richard Van Wagoner, attorney for Steven Brantley, and Steven Brantley, Respondent,

The Presiding Officer reviewed the procedural history of the case.

Mr. Van Wagoner indicated that the parties had reached a settlement whereby Mr. Brantley would be issued a license subject to a 24 month probationary period from the date of issuance. If there are no violations, then the probation would terminate at the end of 24 months. If there are violations, the parties will reconvene and assess how to proceed. Ms. Frohlich confirmed the terms of the stipulation.

Based upon the stipulation of the parties, the Presiding Officer enters the following Order:

**ORDER**

1. Respondent, Steven D. Brantley, is hereby granted a resident producer individual insurance license with Title Marketing Representative and Title Insurance Examiner lines of authority. As a condition of this license being issued, Mr. Brantley is placed on probation for a period of 24 months beginning on the date this Order is signed.

2. During this probation, Respondent shall not violate any Utah Statute or Department Rule.

3. Probation shall be terminated at the end of the 24 month period if there are no violations.

forfeitures of up to \$10,000 per day for continued violation. You are further notified that other jurisdictions in which you may be licensed may require that you report this action to them.


