**NOTICE OF WITHDRAWAL OF

This matter came before the undersigned on April 28, 2023, at 10:00 a.m., for a scheduled telephonic prehearing conference. Shelley A. Coudreaut, Assistant Attorney General, appeared for the Utah Insurance Department (hereafter “the Department”). Respondent Tamara L. Hyatt (hereafter “Respondent”) appeared and was not represented by counsel.

This matter was commenced on April 20, 2023, when Respondent filed a request to appeal and for a hearing regarding Complainant’s imposition of a \$500.00 forfeiture. The matter was scheduled for a telephonic prehearing conference to be held on April 28, 2023.

During the prehearing conference, Respondent stated that she agreed with the Notice of Agency Action and Order and the \$500.00 forfeiture. She just wanted a hearing to explain that she didn't know she was breaking any rules, but understands she is still responsible. Respondent then verbally requested to withdraw her appeal, stating she had not previously understood the applicable provisions of Utah law. Complainant had no objection to Respondent’s withdrawal of her appeal.

ORDER

Based upon the foregoing, and for good cause shown, the undersigned hereby enters the following Order:

1. Respondent's Request for Hearing is **WITHDRAWN**.
2. Respondent's Request for Hearing is therefore **DISMISSED** with prejudice.
3. The Department's Order, dated April 10, 2023, imposing a forfeiture of \$500.00 for violated for violating Utah insurance laws is hereby **AFFIRMED**. The forfeiture shall be paid in full to the Department no later than thirty (30) days after this order is signed.
