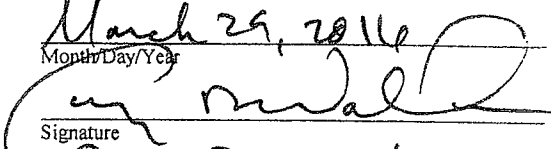

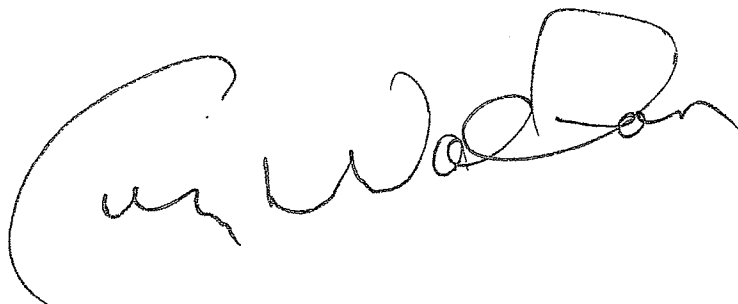
- #3 Forms are not submitted at this time. We are awaiting approval of application prior to printing.

- #2 Gary Walton and Beehive Bail Bonds was the focus of Enforcement Case 2951. Result was a fine and 18 month probation satisfactorily completed.

PAGE 4

- #9 Over twenty years ago, St. George District Court entered some judgments against Beehive Bail Bonds and Gary And Nancy Walton. No collection effort was made until approximately 2010. M. Gale Lemmon with the Utah Attorney General's Office determined the judgments nil and void due to statute of limitations on civil debt. The reference is Utah Code section 78B.
- #11 This question asks if any judgment has been subject to execution. I believe answer to #9 should suffice. Other than St. George, I may have had one forfeiture judgment referred to the Department of Insurance. I can't really recall.
- #12 Documents already forwarded showing officers and registration.
- #13 Gary and Nancy Walton, through either their family trust or personal names, hold title to eight residential properties within the State of Utah.
