 - Bail bond agency reinstatements / Randy
 - Randy says licenses for Freedom Bail Bonds, 007 Bonds, and Pappas Bail Bonds all lapsed effective at midnight on August 14.
 - The UID received on August 15 the reinstatement applications and materials from 007 Bonds and Pappas Bail Bonds. Both have completed applications and supplemental materials, and have paid the reinstatement fees.
 - Randy asks if the Bail Bond Board recommends reinstatement, can the license be reinstated effective August 15 because that's when the applications were received? He says it's possible on the UID's end, but wants to know if the Board wants to do that. Perri isn't prepared to answer that off the top of her head. Clay says he doesn't know the importance of the question, but he hopes they wouldn't have written any bonds while they were lapsed because they shouldn't have been doing business. He hopes that's not why we're asking about a retroactive reinstatement. Reed

agrees and says the statute requires that the Board recommend approval to the UID, and the Board did not do so before August 15. He says August 17 is the correct date. Clay agrees.
