The rule has been filed and the comment period will end 10-15-09.
- **New Business**
 - **“Motion to Submit” as it pertains to the Courts / Gordon**
Gordon provided a copy of a petition. A South Salt Lake judge suggested giving courts seven days to issue a warrant and specifying this in the code. If they fail to meet this deadline the bail bond agency is exonerated from the bond. Mickey suggested that this code change be discussed with the administrator of the court. Go to the meeting as representatives of the Bail Bond Board or Association. If the court agrees perhaps they will put it in their legislation or the department can put it in theirs.
