Complainant, Utah Insurance Department ("Department") and Respondent, Real Advantage Title Insurance Agency, LLC ("Respondent"), have stipulated to entry of the following Findings of Fact, Conclusions of Law, and Order.

Based upon that stipulation, and good cause appearing, the Presiding Officer makes and enters the following:

FINDINGS OF FACT

1. Respondent is a Utah resident producer organization, authorized to do the business of insurance in Utah under license number 365585.
2. Respondent's mailing address is 1792 Bonanza Drive, Suite C100, Park City, UT 84060.
3. Pursuant to Utah Code § 31A-23a-402(2) and Utah Admin. Code R.592-6-4(12)(a)(ii) and

(iii), a licensee may not engage in unfair methods of competition by creating and advertising an unfair inducement for the placement of title insurance business, which includes advertising jointly with a client.

4. On January 30, 2025, and again on February 5, 2025, the Department received two complaints against the Respondent alleging improper joint advertising with a specific realtor firm. The complaints centered on MLS real estate listings where the Respondent's client, a realtor, improperly advertised in its agent remarks a "30% off with concurrent close discount" ("Real Advantage discount") offered by the Respondent, in violation of Utah Code § 31A-23a-402(2) and Utah Admin. Code R.592-6-4(12)(a)(ii) and (iii).

5. As part of a subsequent investigation by the Department, the Respondent identified eleven closed files involving the realtor firm. Of those eleven files, seven had MLS real estate listings explicitly showing the joint advertising of the Real Advantage discount. This was in addition to the two complaints received that also showed the MLS joint advertising.

6. As a result of the Respondent's violations, the Department and Respondent have agreed to an administrative forfeiture of \$2,940.21

CONCLUSIONS OF LAW

1. The Utah Insurance Commissioner ("Commissioner") has jurisdiction over the parties and this adjudicative proceeding pursuant to Utah Code §§ 31A-1-105 and 31A-2-201.

2. The Commissioner has legal authority to impose penalties on the Department's licensees who violate the Utah Insurance Code pursuant to Utah Code § 31A-2-308.

3. Pursuant to Utah Code § 31A-23a-402(2) and Utah Admin. Code R.592-6-4(12)(a)(ii) and (iii), a licensee may not engage in unfair methods of competition by creating and advertising an unfair inducement for the placement of title insurance business, which includes advertising jointly with a client.

4. The Respondent's client, a realtor, improperly advertised in its MLS real estate listing agent remarks a "30% off with concurrent close discount" ("Real Advantage discount") offered by the Respondent, in violation of Utah Code § 31A-23a-402(2) and Utah Admin. Code R.592-6-4(12)(a)(ii) and (iii).

5. The Respondent identified eleven closed files involving the realtor firm. Of those eleven files, seven had MLS real estate listings explicitly showing the joint advertising of the Real Advantage discount, in addition to the two complaints received that also showed the MLS real estate listing joint advertising.

4. As a penalty for the violations in this case, the Respondent should be ordered to pay a forfeiture of \$2,940.21

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, it is hereby Ordered that:

1. Respondent shall pay a forfeiture of \$2,940.21 for the violations described in the Conclusions of Law. The forfeiture shall be paid in full to the Department no later than thirty (30) days after this order is signed.

2. Respondent is ordered not to commit the violations described in the Conclusions of Law in the future.

3. The issuance of the signed and adopted Order is solely for the purpose of disposing of the specific matter entitled therein. Only promises, agreements, and



Complainant, Utah Insurance Department ("Department") and Respondent, United West Title Insurance Agency, Inc., ("Respondent") have stipulated to entry of the following Findings of Fact, Conclusions of Law, and Order.

Based upon that stipulation, and good cause appearing, the Presiding Officer makes and enters the following:

FINDINGS OF FACT

1. Respondent is a resident producer organization holding Utah license number 331550.
2. Respondent's mailing address is 1548 W. 1825 N., Provo, UT 84604-1105.
3. During the Department's annual report review, the Department found that Respondent had not properly identified three trust accounts and two sweep accounts as trust accounts.

4. Utah Code §§ 31A-23a-406(2)(d)(ii), 31A-23a-409(2)(a), and Utah Admin. Rule R590-170-4(1)(a)(b)(ii) require trust accounts to be labeled as trust accounts.
5. In addition, Respondent's own Trust and Premium Trust Account process mandates that escrow/trust accounts be clearly identified as such on all documentation.
6. The Respondent has since corrected the account labeling.
7. The Department and Respondent have agreed to an administrative forfeiture of \$1,500.00 against Respondent for failing to respond to the survey by the deadline.

CONCLUSIONS OF LAW

1. The Utah Insurance Commissioner ("Commissioner") has jurisdiction over the parties and this adjudicative proceeding pursuant to Utah Code §§ 31A-1-105 and 31A-2-201.
2. The Commissioner has legal authority to impose penalties on the Department's licensees who violate the Utah Insurance Code pursuant to Utah Code § 31A-2-308.
3. Respondent violated Utah Code §§ 31A-23a-406(2)(d)(ii), 31A-23a-409(2)(a), and Utah Admin. Rule R590-170-4(1)(a)(b)(ii), by failing to correctly identify and label three trust accounts and two trust sweep accounts.
4. As a penalty for the violations in this case, the Respondent should be ordered to pay a forfeiture of \$1,500.00.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, it is hereby Ordered that:

1. Respondent shall pay a forfeiture of \$1,500.00 for the violations described in the Conclusions of Law.
2. The forfeiture shall be paid in full to the Department no later than thirty (30) days

after this order is signed.

3. Respondent is ordered not to commit the violations described in the Conclusions of Law in the future.

Based upon that stipulation, and good cause appearing, the Presiding Officer makes and enters the following:

FINDINGS OF FACT

1. Respondent is a resident producer organization holding Utah license number 2733.
2. Respondent's mailing address is 14884 S. Heritage Crest Way, Ste. C, Bluffdale, UT 84065-4840.
3. In February 2025, the Department began investigating a consumer complaint regarding Respondent's handling of a closing in December 2024.

4. At the time of closing, the settlement statement indicated that the buyer was to receive a credit of \$250.00 in addition to the excess cash of \$303.28, for a total disbursement of \$553.28.

5. On December 27, 2024, Respondent disbursed only \$303.28 to the buyer, after unilaterally altering the disbursement amount on the settlement statement.

6. Respondent paid the real estate broker \$9,550.00 instead of the \$9,300.00 that should have been paid after the \$250.00 credit.

7. On February 11, 2025, Respondent mailed a check for \$250.00 to the buyer.

8. The Department and Respondent have agreed to an administrative forfeiture of \$717.24 against Respondent.

CONCLUSIONS OF LAW

1. The Utah Insurance Commissioner (“Commissioner”) has jurisdiction over the parties and this adjudicative proceeding pursuant to Utah Code §§ 31A-1-105 and 31A-2-201.

2. The Commissioner has legal authority to impose penalties on the Department's licensees who violate the Utah Insurance Code pursuant to Utah Code § 31A-2-308.

3. Respondent violated Utah Code §§ 31A-23a-409(1)(c) and did not exercise a high standard of care to reasonably preserve and protect the money held in escrow by failing to follow the settlement statement and altering the disbursement amount to the buyer.

4. Respondent violated Utah Code §§ 31A-23a-406(5)(c), by disbursing escrow funds before the conditions of escrow were fully met.

5. As a penalty for the violations in this case, the Respondent should be ordered to pay a forfeiture of \$717.24.

ORDER

that:

1. Respondent shall pay a forfeiture of \$717.24 for the violations described in the Conclusions of Law.



TEC Marketing Question #1

I have a question regarding unfair inducements.

Does it constitute an unfair inducement if an employee of a title insurance company also works for or volunteers at a company that requires title insurance and has direct influence over the selection of the title insurance provider?

Example 1: Employee of ABC Title Company is a board member of XYZ Lending Company. Being a member of the board is strictly a volunteer position. However, part of the board members duties is to "vote on and approve loans that may or may not require title insurance."

Example 2: A 1099 employee of ABC Title works with Acme lending company and does have influence on direction of where closing take place?

I have seen this on the commercial lending side not on the residential side.
